Discussions focused on several vital topics:

- Enhancing the Verification System for Input VAT Claims
- Reevaluating the SVAT Scheme for Exporters and Indirect Exporters
- Urgently Upgrading Electronic Filing Infrastructure
- Rectifying Inaccurate Interest Charges in the RAMIS System

The meeting concluded on a positive note, with both parties pledging to work together on these urgent matters. The dialogue highlighted the necessity of ongoing communication between the private sector and government entities to develop a more effective and fair tax framework in Sri Lanka.
