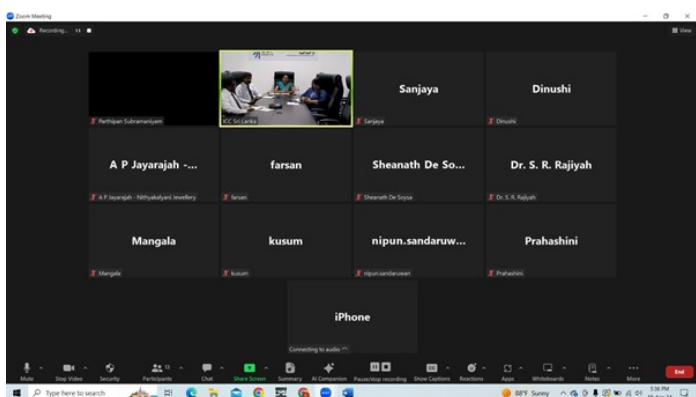

20th June 2024

The representatives from the ICC Sri Lanka Research, Knowledge Mobilization, and Taxation Committee met with the Department of Inland Revenue Sri Lanka to discuss important areas identified through online discussions with ICC Sri Lanka members. The discussed areas include:

1. Development of an equitable and transparent VAT registration process.
2. Establishment of a robust input VAT recovery mechanism under RAMIS.
3. Enhancement of electronic filing infrastructure.
4. Request to revisit the recent policy change on tax remittance via cheques.
5. Advancement of transparency through public listing of VAT registered persons.
6. Simplified Value Added Tax (SVAT) issues for exporters and export support services.

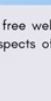
